Dear Chairman Scott, Chairwoman Murray, Representative Foxx, and Senator Burr,

The undersigned organizations write to you to express our support for H.R. 2525/S. 774, the "Report and Educate About Campus Hazing (REACH) Act," and urge the Committee to consider and favorably report the REACH Act to the House and Senate floor for a vote. The bill, introduced by a bipartisan group of lawmakers, would promote campus safety and be an invaluable tool in hazing prevention efforts - keeping students safe and alive at school.

Fifty-five percent of college students involved in clubs, teams, and organizations experience hazing.<sup>1</sup> Hazing is a threat to the health and safety of students due to its intimidating, harassing, and often violent nature.<sup>2</sup> At extremes, hazing is lethal. In March of 2007, Gary and Julie DeVercelly's son, Gary DeVercelly Jr., died as a result of hazing at Rider University. As board members with Clery Center, they have been tireless advocates to ensure no parents have to experience this unbearable—and preventable—loss. Tragically, hazing continues to have a lasting impact on individuals, families, and communities across the country.

In the first quarter of 2021 alone, three more young-adult lives were tragically lost due to alleged hazing incidents, including James Gilfedder of California and student at Lyon College in Arkansas, Adam Oakes of Virginia and student at Virginia Commonwealth University, and Stone Foltz of Ohio and student at Bowling Green State University.

While a hazing-related death has occurred, on average, every year since the mid-1900s, state anti-hazing laws are uneven at best and sometimes non-existent. Only 44 of the 50 states have a hazing-related statute and there is currently no universal requirement for colleges or universities to collect and publish information on reports of hazing or related policies. The state in which a student chooses to attend college should not dictate their safety in regard to hazing.

The REACH Act works to remedy these issues by creating a nationwide standardized definition of hazing, including hazing incidents as crime statistics in Annual Security Reports (ASRs) under the Jeanne Clery Act, and requiring that colleges and universities provide evidence-informed hazing prevention education to their communities in an effort to prevent such incidents. This bill is clear, concise, and creates transparency and consistency across all postsecondary institutions. The more time that passes before legislation is enacted, the more likely it is that students will be harmed and even killed by these senseless acts.

On behalf of the undersigned organizations, thank you for taking the time to consider our views on this piece of legislation and we urge the Committee to consider and favorably report the REACH Act.
